Chair Mitchell stated that the State requested that the Board review and accept the June 30, 2014 Police Public Safety Personnel Retirement System Actuarial Report. Internal Services Director, Renie Broderick, called the Boards attention to contribution rates. The June 30, 2013 contribution rate for fiscal year ending 2015 is 35.12 percent; new rates effective for fiscal year ending 2016 will be 44.7 percent. Motion by Russell Schoeneman to accept the June 30, 2014 Actuarial Report; second by Joe Brosius. Motion passed unanimously on a voice vote 5-0.
