

RESOLUTION NO. 2011.38

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, APPROVING CERTAIN EXTERNAL ORGANIZATIONS TO APPLY FOR FUNDS FROM THE GILA RIVER INDIAN COMMUNITY.

WHEREAS, Arizona Revised Statute § 5-601.02 authorizes gaming contracts between the State of Arizona and Arizona tribes and permits the establishment of the Gila River State Shared Revenue program that now provides funds to eligible applicants such as cities, towns and counties, and

WHEREAS, The Centers for Habilitation is applying for Gila River Indian Community Grant Funds supporting J.O.B.S. (Journey for Overcoming Barriers for Successful Employment) as further set forth in its application, and

WHEREAS, Central Arizona Shelter Services (CASS) is applying for Gila River Indian Community Grant Funds supporting Central Arizona Shelter Services Employment Services as further set forth in its application, and

WHEREAS, Tempe Family YMCA is applying for Gila River Indian Community Grant Funds supporting Youth Wellness Center as further set forth in its application, and

WHEREAS, Jobs for Arizona Graduates (JAG) is applying for Gila River Indian Community Grant Funds supporting Tempe JAG Programs as further set forth in its application, and

WHEREAS, Tempe Community Action Agency (TCAA) is applying for Gila River Indian Community Grant Funds supporting Tempe Interfaith Homeless Emergency Lodging Program (IHELP) as further set forth in its application, and

WHEREAS, Tempe Union High School District is applying for Gila River Indian Community Grant Funds supporting Safety and Security at Tempe Union High School District High Schools as further set forth in its application, and

WHEREAS, East Valley Adult Resources (EVAR) is applying for Gila River Indian Community Grant Funds supporting East Valley RSVP as further set forth in its application, and

WHEREAS, Association for Supportive Child Care (ASCC) is applying for Gila River Indian Community Grant Funds supporting Phone Friend Program as further set forth in its application, and

WHEREAS, Arizona Academy of the Performing Arts is applying for Gila River Indian Community Grant Funds supporting Summer Residency Program as further set forth in its application, and

WHEREAS, the Gila River Indian Community is offering grants to cities, towns, or counties under their state shared revenue agreement, and

WHEREAS, each funding request would support the programs listed above as further set forth in their applications,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, as follows:

That the City of Tempe approves the following organizations to apply for funds from the Gila River Indian Community for the purpose of supporting programs as further set forth in their applications:
